The only contract in place between WDC and Aukaha during those four financial years was a contract in relation to the District Plan review in 2023, for a total of \$11,360 plus GST and disbursements.

No further monies were paid to iwi representatives in addition to committee membership salaries.

The only contract currently in place is between WDC and Aukaha, in relation to the Forrester Gallery project that commenced in August 2024, for a total cost of \$60,832.50.
